**COVID UPDATE:** 

Use of Building by "non-UUFEC" folk. Jane would like to confirm that "previous" groups can use building if they agree to our guidelines adopted in May. (PFLAG Niceville has inquired about building use, and we had two support groups that may want to resume meeting, within the new guidelines).

BOARD AGREED THAT ALL OUTSIDE GROUPS MUST FOLLOW THE CURRENT COVID BUILDING USE POLICY, JUST AS UUFEC MEMBERS MUST. THIS INCLUDES THAT GROUPS MUST SIGN THE BUILDING USE WAIVER

WE REVIEWED THE RULES FOR COVID BUILDING USE. WE SPECIFICALLY INTERPRETED THE RULES TO ALLOW FOUR GROUPS OF 8 TO MEET SIMULTANEOUSLY- AND JUST KEEP DISTANCE OF 6 FEET TWEEN GROUPS.
